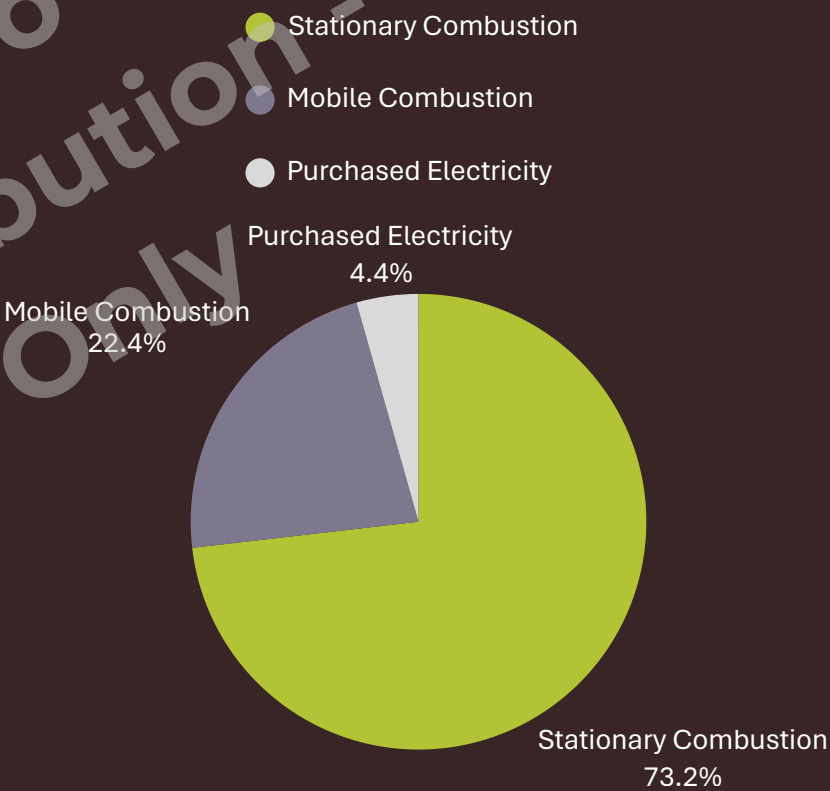

Inventory Methods and Assumptions

This carbon footprint report has been prepared for the year 2025, with emissions forecasts through to 2035 and a net-zero target set for 2050. It focuses on *Make It Yours'* operations and provides a comprehensive overview of emission sources, associated activity data, underlying assumptions, limitations, and estimated emissions to support forecasting efforts.

Data was collected through one main stream. Location-based emissions include Scope 1 direct emissions and Scope 2 electricity consumption.

All emissions presented in this report were calculated using established emissions factors. Scope 1 and Scope 2 emissions were calculated using factors from the Australian National Greenhouse Accounts (Aug 2024).

This analysis is based on the best available data at the time of preparation and has been developed in line with ISO 14064-1, the Greenhouse Gas Protocol standards and guidance, and the requirements of the National Greenhouse and Energy Reporting (NGER) Act 2007. The report will be revised as more accurate data, updated methodologies, or new emissions factors become available, or in the event that any significant errors are identified.
